
- (i) Candidates who have applied earlier against advertisement No. 07/2022, need not apply again, as their previous online application form will be considered, if found eligible.
- (ii) Educational qualification of applicants will be determined as on the last date for submission of online application to the Commission i.e. **21.10.2024**.
- (iii) Age of applicants will be determined as on **21.10.2024**.
- (iv) The candidates who are applying against this corrigendum and belonging to **Economically Weaker Section (EWS)** category of Haryana are required to submit necessary certificate as per Haryana Govt. instructions issued vide No. 22/12/2019-1GS-III dated 25.02.2019 (available on the website of C.S. Haryana i.e. <http://csharyana.gov.in/>) issued by the Competent Authority. This certificate should be valid for the financial year **2024-25**.
- (v) The candidates who are applying against this corrigendum and belonging to BC-A or BC-B are directed to upload the fresh/latest BC-A or BC-B certificate, as the case may be, as per Haryana Government notification No.22/132/2013-1 GS-III dated 22.03.2022 and notification dated 16.07.2024. This certificate should be

issued in the financial year 2024-25. (In case of Female candidates, the certificate should be issued from father's side).

- (vi) Other terms & conditions mentioned in the advertisement No. 07/2022 dated 14.03.2022 shall remain unchanged.
- (vii) Candidates who had erroneously filled wrong particulars relating to their category, educational qualifications etc. previously may apply afresh through the online mode.

Note: The candidates who are belonging to BCA (Creamy Layer)/BCB (Creamy Layer), will be considered as General Category candidates and their fee will be at par with General Category i.e.Rs.1000/-.
