4. The provisionally shortlisted candidate will have to mandatorily upload his/her document by logging into the website [www.apssb.nic.in](http://www.apssb.nic.in) using their credentials from 12.10.2024 (10.00 AM) to 17.10.2024 (03.00 PM). The following documents are to be uploaded:

- i. Recent passport size Photograph (2 copies).
- ii. Matriculation certificates issued by the Board/ Institute for proof of date of birth.
- iii. Class XII pass certificate & mark sheet issued from a recognized Board/University.
- iv. APST Certificate (if applicable).
- v. PwBD certificate (for candidates applying for vacancies reserved for PwBD).
- vi. Print out of Admit Card.
- vii. Any other documents as may be relevant.

5. Failure to upload documents shall result in rejection of candidature and non-allotment of post.

6. The provisionally shortlisted candidate should bring their original documents and photocopy of the documents mentioned at 4 (i) to 4 (vii) on the day of Skill Test and Document Verification.


7. The candidature of all the shortlisted candidates is PROVISIONAL and subject to their eligibility in all respects as prescribed in the Advertisement and Recruitment Rules.

8. Candidates must note that their candidature is purely provisional at this stage and their appointment will be subject to their name figuring in final select list which shall be



prepared after the completion of Skill (Typing) Test and Document Verification. Apart from that they should fulfil the eligibility criteria as per Advertisement No.7/2024 dated 15.07.2024, including possession of the requisite documents, failing which their candidature may be summarily rejected at any stage.


9. Further, the Appointing Authority i.e., the indenting / user department verifies the character and antecedents of the candidates, authenticity of documents/ certificates and eligibility as per the Recruitment Rules before finally appointing the candidate(s). Therefore, the provisional short listing of a candidate does not confer upon him/ her any right of appointment unless the Appointing Authority is satisfied, after such inquiry as may be considered necessary, that the candidate is suitable in all respects for appointment to the post.
