# Grade 'C' Stenographers Limited Departmental Competitive Examination, 2020, 2021 & 2022: Declaration of final result for the year 2020

The Staff Selection Commission conducted Computer Based Examination for Grade 'C' Stenographers Limited Departmental Competitive Examination, 2020, 2021 & 2022 on 06.02.2024 for making additions to the Select list for Grade 'C' of the following Services/Cadres/Ministries:-

The result of Computer Based Examination for Grade 'C' Stenographers Limited Departmental Competitive Examination, 2020, 2021 & 2022 was declared by the Commission on 12.03.2024 wherein 807 candidates qualified for appearing in Skill Test in Stenography for the year 2020. Subsequently, Skill Test was conducted by the Commission on 24.04.2024. The Commission declared the result of Skill Test on 05.07.2024 for evaluation of APARs of candidates who qualified in the Skill Test of the said examination.
