**ENGAGEMENT OF GUEST FACULTY**

Central University of Kerala intends to engage Guest Faculty for the following subjects for Integrated Teachers Education Programme (ITEP) :-

English	01	ST	i) Master's Degree in English with minimum 55% marks ii) B Ed Degree with minimum 55% marks or equivalent Grade. iii) National Eligibility Test or PhD in Education or concerned subject
Economics	01	SC	i) Master's Degree in Economics with minimum 55% marks ii) B Ed Degree with minimum 55% marks or equivalent Grade. iii) National Eligibility Test or PhD in Education or concerned subject
Commerce	01	OBC	i) Master's Degree in Commerce with minimum 55% marks ii) B Ed Degree with minimum 55% marks or equivalent Grade. iii) National Eligibility Test or PhD in Education or concerned subject

**General**

Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC or the CSIR, or a similar test accredited by the UGC, like SLET/SET or who are or have been awarded a Ph. D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degree) Regulations, 2009 or 2016 and their amendments from time to time as the case may be exempted from NET/SLET/SET. Further, similar test accredited by the UGC like SLET/SET shall be valid as the minimum eligibility in the respective state only:


*Provided* further that the award of degree to candidates registered for the M.Phil/Ph.D Programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances / Bye-laws / Regulations of the Institutions awarding the degree. All such Ph.D. candidates shall be exempted from the requirement of NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/Institutions subject to the fulfillment of the following conditions. Further, SLET/SET shall be valid as the minimum eligibility for direct recruitment to Universities/Colleges/Institutions in the respective state only

- The Ph.D. degree of the candidate has been awarded in regular mode only;
- The Ph.D. thesis has been awarded by at least two external examiners;
- An open Ph.D. viva voce of the candidate has been conducted;
- The candidate has published two research papers from his/her Ph.D. work out of which at least one is in a refereed journal;
- The candidate has presented at least two papers, based on his/her Ph.D. work in conferences/seminars sponsored/funded/supported by the UGC/ ICSSR/CSIR or any similar agency.

*The fulfillment of these conditions is to be certified by the Registrar or the Dean (Academic Affairs) of the University concerned.*

### General Instructions

1. Selection will be conducted through Walk-in-Interview. Information on the date of interview will be uploaded in the University website [www.cukerala.ac.in](http://www.cukerala.ac.in). Interested candidates may forward their application in advance (in the prescribed format attached herewith) along with updated CVs to E-mail ID – [est.teach@cukerala.ac.in](mailto:est.teach@cukerala.ac.in). The validity of this notification for each post will be automatically ceased after the date of walk-in-Interview for respective subjects.
2. **For the post reserved for SC/ST/OBC :-** If candidates fulfilling the eligibility conditions mentioned above are not available for the posts reserved for SC/ST/OBC, the University may fill up the posts from UR Category . Hence, interested candidates belonging to all categories may send their applications against the post reserved for SC/ST/OBC. Information regarding Walk-in-Interview will be given to those candidates depends upon the availability of candidates under SC/ST/OBC Category.
3. The appointment is purely on temporary basis and is for a maximum period of one semester or until a permanent faculty joins the concerned Department whichever is earlier.
4. Retired teachers up to the age of 70 Yrs may also attend.
5. Anything which is not mentioned in this notification will be dealt as per the Rules of the University
